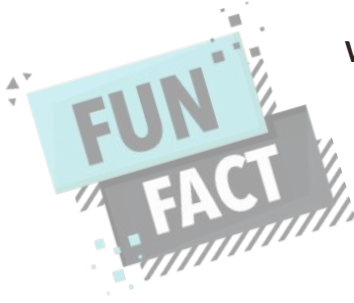

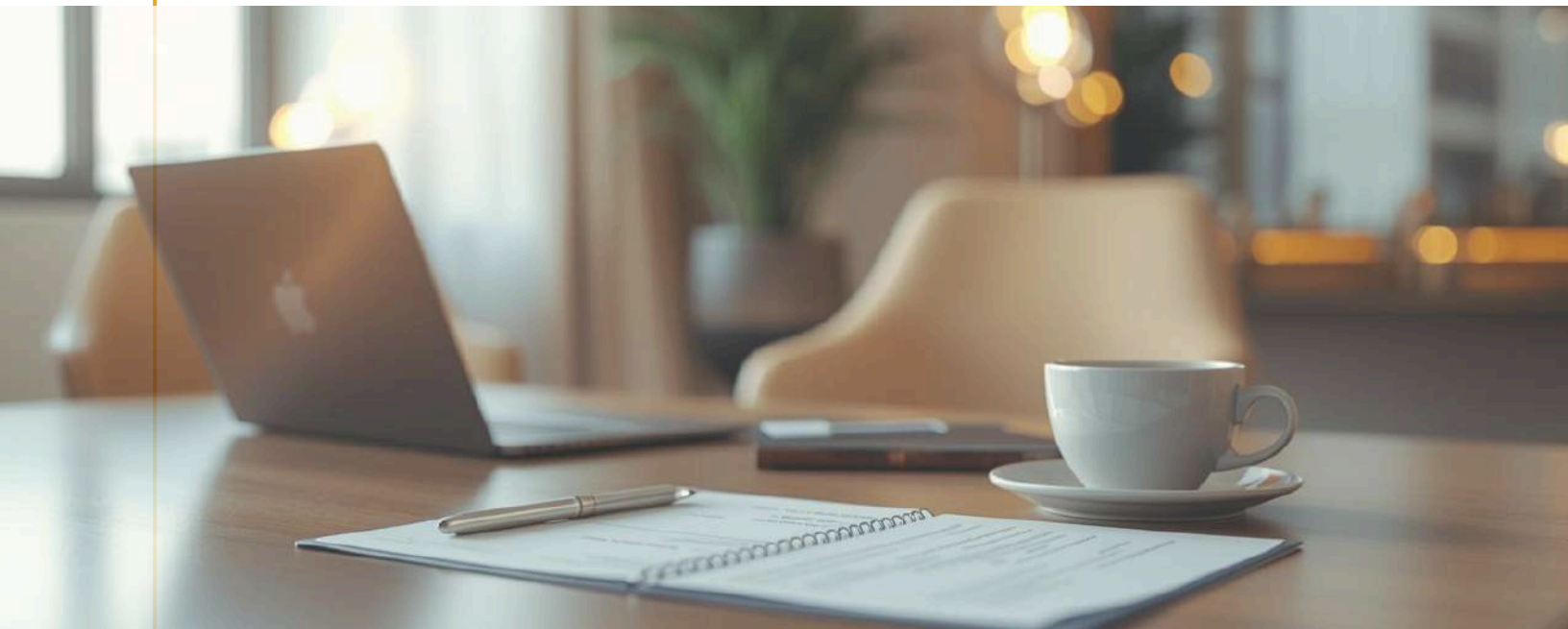

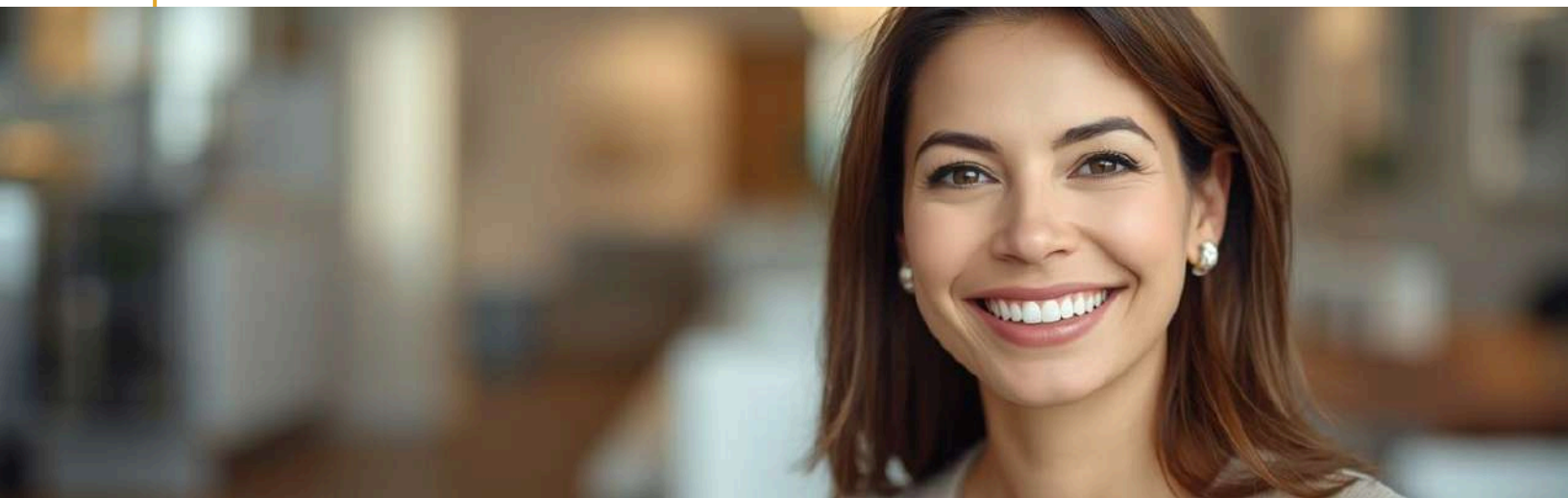

Frequently Asked Questions

Is there an onboarding cost?

Yes — a \$299 Agent Registration Fee secures your dedicated spot on our desk.

This includes your:

- Personalized timeline
- Branded signatures
- Review request templates
- Agent-specific automations & touchpoints

You set it up once

then every file runs smoother.

What if the contract cancels?

No fee during the Inspection Period.

After that, a \$75 compliance fee applies.

If the customer goes back under contract within 30 days, that fee is credited to the next file.

(If a deal falls through twice, the fee does not transfer — clarity is kindness.)

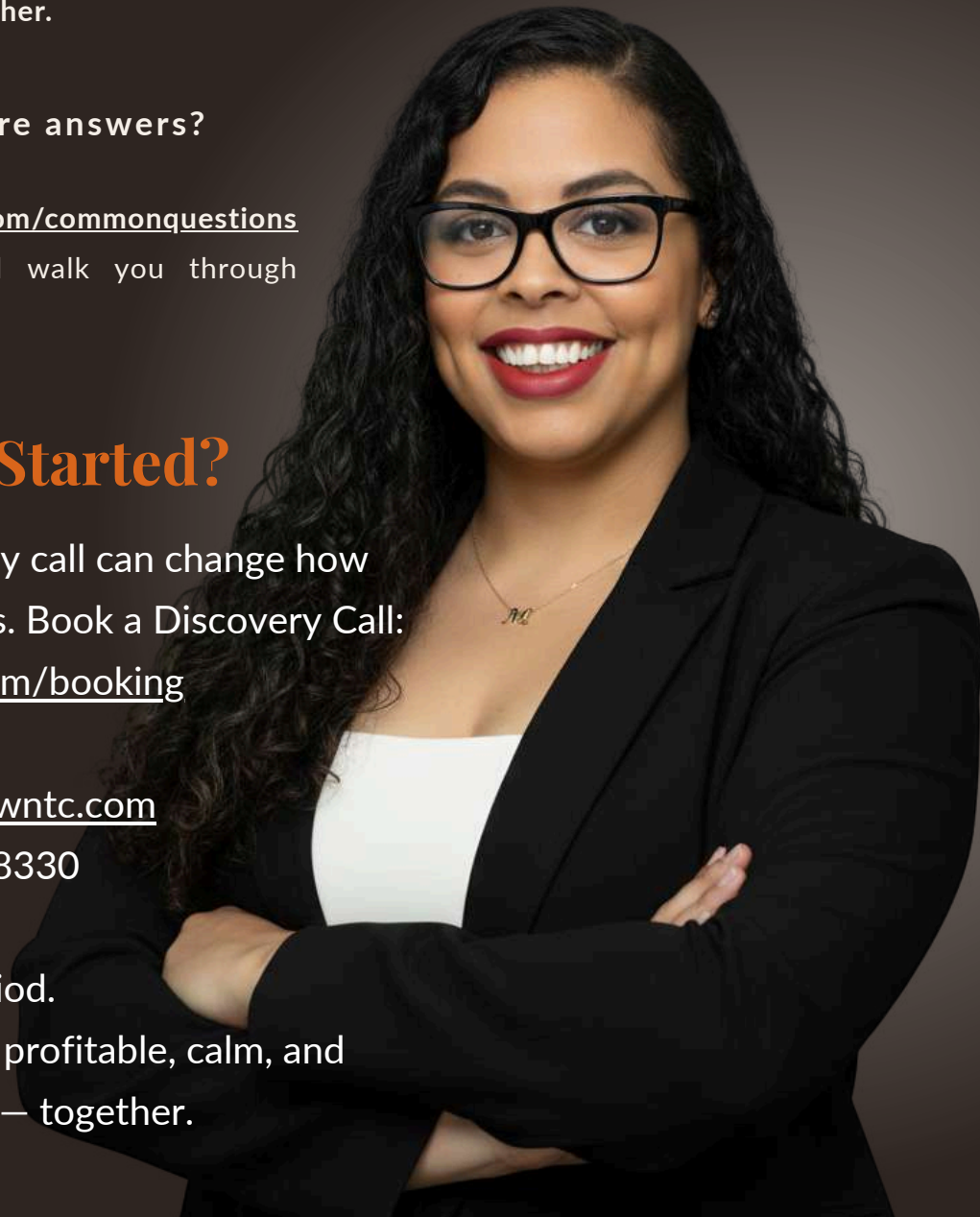
